- 6. Foundation governors:
 - a. 1 foundation governor will be ex-officio and subject to paragraph 7(a).b. 1 foundation governor will be appointed by the Diocesan Board of Education.
- 7. a. The holder of the following office shall be an ex-officio foundation governor: The principal officiating minister (i.e. the incumbent or priest in charge of the parish in which the church school is situated or a team vicar with special cure of souls for the area in which the school is situated).

b. The appropriate Archdeacon shall appoint a foundation governor to act in

the place of the ex-officio foundation governors whose governorship derives from the office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21(2) of the Constitution Regulations.

- 8. The appropriate Archdeacon may request the removal of the ex-officio governor and may appoint any substitute governor.
- 9. Milton Ernest Church of England Primary School is held in a religious trust.
- 10. The religious ethos of Milton Ernest Church of England Primary School:
 - To serve its community by providing an education of the highest quality within the context of a shared set of values and Christian belief and practice.
 - To encourage an understanding of the meaning and significance of faith, and promote Christian values through the experience it offers to all its pupils.
 - Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.
