#### **1.Introduction**

Milton Ernest is a village of around 600 residents based in North Bedfordshire. Our small school is set at the heart of the village and serves children between the ages of 4 and 9 years. The school is part of a federation with Eileen Wade Lower School.

At Milton Ernest VC Lower School we believe that education enriches people's lives and aspirations. We value everyone and strive for all to reach their full potential. We base our work on the principle that children learn most effectively in a secure, exciting, challenging and inclusive environment that nurtures a life - long love of learning. As a Church of England school, Christian faith is central to our school's way of learning and living. We work in partnership with parents, the local community, All Saints Church, other schools in the area and fellow professionals to build our children's social, emotional, intellectual, physical, spiritual and ethical skills.

# **Our Aims:**

- To provide the best possible education for each child through the delivery of a broad and balanced curriculum that matches individual needs and aspirations
- To provide a secure, happy and stimulating learning environment in which children are challenged and encouraged to take risks
- To enable children to become numerate, literate, creative and curious
- To promote a healthy life style
- To nurture an atmosphere in which children, parents, staff and community feel part of the school family
- To encourage mutual respect, confidence, co-operation and self-esteem
- To help our children to understand and respect other cultures, beliefs and faiths so that they celebrate diversity and have no fear of difference
- **1.1. Reason for STP**: This School Travel Plan (STP) is being developed to support the planning application for the expansion/extension of the upper age limit of Milton Ernest Lower School and enlarge the physical capacity to establish a primary school with an age range from 4 years (Reception) to 11 years (Year 6).

# 1.2. Proposed additional Pupil numbers from 2017

The current capacity of Milton Ernest Lower School is 60 places. It is proposed that from 1 September 2017 the capacity will increase to 72 places (12 places in Year 5) and from 1 September 2018 the capacity will increase to 84 places (12 places in Year 6). This will require 1 additional classroom for Years 5 and 6.

The earliest any changes could take place would be from September 2017. The effect for our school would see an expansion upwards to Year 5 in September 2017, Year 6 in September 2018 and then children would enter the Secondary School at Year 7 in September 2019.

We intend to take the following actions based on our hands up survey data to promote sustainable travel:

#### 6.1. New Objectives March 2016 till April 2017

**I.** Promote the health benefits of sustainable travel to the whole school community by utilising the school Games Committee and its work on Healthy Living in Schools.

**II.** Continue to promote the importance of road safety education, reinforced every time the pupils cross Thurleigh Road to use the Village Hall.

**III.** Aim to maintain number of single car occupancy travel to the school after proposed school expansion.

**IV.** Promote use of car share and use of local buses wherever possible.

# 6.2. New Targets March 2016 till April 2017

I. To have Year 4 children receive bikeability training by April 2017.

II. To have 100% of Year 4 children receive Road Safety Education by April 2017.

**III.** Take part in Bedford Borough's Annual Stepping out Safely young road user programme targeted at Reception & Year 3 children by April 2017.
